Directions to All Park Locations

Golden Valley - Wesley Park (8121 Wesley Drive)

- A. From Hwy 169: Take Plymouth Ave to the east and proceed to Winnetka Ave N. Go north on Winnetka Ave N to Wesley Drive. Turn left (west) on Wesley Drive and park is two blocks from Winnetka Ave N.
- B. From Hwy 100: Take Hwy 55 west to Winnetka Ave N. Proceed north on Winnetka to Wesley Drive. Turn left (west) on Wesley Drive and park is two blocks from Winnetka Ave N.

Hopkins - Central Park (11000 Excelsior Blvd)

A. From the intersection of 169 and 394, go south on 169 to Excelsior Blvd. Go west on Excelsior Blvd approximately 1 mile to Central Park/Hopkins Pavilion, 11000 Excelsior Blvd. The hockey rink is located just north of the Hopkins Pavilion.

Plymouth - LaCompte Playfield (10805 Old County Road 15)

- A. From Hwy 169 West on Hwy 55 South (L) on "Revere Lane" West (R) on "Old Cty Rd 15" about 3 blocks down/park will be on left.
- B. From Hwy 494 East on Hwy 55 South (R) on "Old Cty Rd 15" or Cty Rd 15 stay on Old Cty Rd 15 past the Plymouth Metrolink park will be on right.

Robbinsdale - Sanborn Park (42nd and Chowen)

A. Take Hwy 100 north to the 42nd Ave. N. exit. Turn right on 42nd and proceed to CR-81. Turn right on CR-81 and proceed 40th. Turn left on 40th, Sanborn Park is on the left side of the street across from Crystal Lake.

St. Louis Park - Nelson Park (2500 Georgia Ave S) This Park is not highlighted on Google but follow the directions and takes you right to it. Limited parking, so please follow parking signs.

- A. From Hwy 100: Go west on Minnetonka Blvd to Georgia Ave turn right on Georgia. Continue on Georgia until you drive right into the park.
- B. From Hwy 169: Go east on Minnetonka Blvd to Georgia Ave, turn left on Georgia. Continue on Georgia until you drive right into the park.
