NOTICE IS HEREBY GIVEN that sealed bids will be received by the City of Plymouth at Plymouth City Hall located at 3400 Plymouth Boulevard until 10:00 A.M. on Thursday, April 4, 2019 at which time they will be publicly opened and read aloud.

Bids are being requested on Hot Mix Asphalt Materials for 2019.

All bids shall be submitted on forms provided which will be furnished free to each bidder upon request. Contractors desiring a copy of the Bid Forms and Contract Documents may obtain them from the City of Plymouth Web Site at www.plymouthmn.gov/bids or by contacting Torrey Keith, Street Supervisor, at 14900 23rd Av. N, Plymouth, Minnesota 55447 or Telephone: (763) 509-5992.

No bidder may withdraw their bid within forty five (45) days after scheduled time of opening bids without the consent of the City.

The City of Plymouth reserves the right to reject any/or all bids or parts of bids and to waive any informalities therein and to accept that bid which is in the best interest of the City of Plymouth as determined by the City Council.

INSTRUCTIONS TO BIDDER

1. Sealed Bids will be accepted until 10:00 A.M. April 4, 2019.
2. Bids shall be in sealed envelopes endorsed "Hot Mix Asphalt Prices ".
3. Bids shall be submitted on the proposal form herewith attached and shall be in accordance with attached specifications.
4. The bid tabulations and recommendations will be submitted to the City Council for consideration at the first available regular meeting after the opening of the bids.

SPECIFICATIONS

It is the City's intend to seek competitive bids for Hot Mix Asphalt materials needed for work during 2019 for street repairs and paving streets and over bike/walking trails.

All Hot Mix Asphalt materials are to meet Minnesota Department of Transportation Standards and Specifications.

All Hot Mix Asphalt Material will be picked up by the City.

In determining the low bidder for a particular job site, the City will factor in \$3.00 per mile from the Hot Mix plant to the job site in recognition of the City's hauling costs. Multiple bids may be approved because the low bid for a job site may be dependent upon the distance from the Hot Mix plant to a particular job site.

The City reserves the right to purchase asphalt from another responsible bidder in cases of long waiting lines, breakdown of plant equipment, and if the quality and quantity of asphalt is not available.

Last year the City purchased approximately 13,000 tons of Hot Mix Asphalt materials from various suppliers.
