ALCOHOL IN PARKS PERMIT INFORMATION

Permit Restrictions

Permits allowing alcohol in the parks must accompany a shelter rental or special event permit. Permits must be submitted at least *two weeks prior to an event

Park Shelters

Alcohol consumption is restricted to shelter covered area only. Alcohol is not allowed on sand/beach space.

Park Buildings

Alcohol consumption is restricted to within the building.

Alcohol - NOT FOR SALE

Alcohol must be 1) provided/brought in by the private party, OR 2) provided by a licensed caterer.

Alcohol - FOR SALE

Alcohol must be 1) provided by a licensed caterer OR 2) served by non-profit, religious or charitable organization who have been in existence for at least three years and have obtained a license to sell alcohol at the permitted event.

If selling alcohol, application must be received at least 60 days prior to event

Safety Review

Events with expected attendance over 100 sold are subject to review by the Plymouth Police Department. Any event not following rental policies or serving alcohol without an administrative permit can be shut down by Plymouth Police.

Insurance

If working with a licensed caterer who carries their own liquor/alcohol insurance, additional insurance is not required. If working with a non-profit or charitable organization to sell alcohol, insurance is required - General Liability of \$1 million and \$2 million aggregate.
