2023 Budget Goals

- Continue to provide high quality services to all existing residents and businesses
- Utilize tax base from new growth to provide the same level of high-quality city services to new areas of the city
- Be sensitive to property tax increases and their impact on taxpayers
- Address identified operational and capital needs for all departments
- To the extent possible, address capital and equipment needs now by not deferring replacement to future years
- Utilize annual budget surpluses for one time capital needs thus reducing future fiscal obligations
- Utilize the 10-year financial plan to insure we are setting the course for long term financial stability



2023 Budget Factors

Salary & Benefits

- 3% for non-represented employees
- Health insurance adjustments
- 10.4 additional positions

Maintain focus on capital investments

1.1% increase in tax base from new construction

Debt Levies

- Plymouth Community Center (second year full levy)
- Fire Station Projects (partial levy)

Economic Challenges

- Inflation
- Utility Costs
 - Example: 23% increase, or approximately \$719,520, to utility costs for all funds over the 3% that was budgeted in the concept budget - electricity, natural gas and fuel








Property Tax Dollar - 2023 Residential Homesteaded Property
