Reducing Loss from Worthless Checks

Worthless checks cost businesses and consumers millions of dollars a year. Many businesses simply accept these losses as a cost of doing business. To help businesses deal with this problem, the Plymouth Police Department has partnered with Financial Crimes Technology Services (FCTS) to implement the Bad Check Diversion Program. The Bad Check Diversion Program is *free* to all Plymouth residents and businesses.

The Program has four main goals:

- To increase the amount of restitution returned to victims;
- To increase the accountability of those who issue bad checks, regardless of the amount;
- To educate businesses and residents about how to reduce the number of worthless checks they receive; and
- To reduce the risk of repeat bad-check activity.

Any NSF, Account Closed, Refer to Maker, Stop Payment, or electronic check *less than* \$500.00 received in Plymouth is eligible for the program. If you receive one of these checks, the FCTS will enter the check into their database. They will then contact the check writer. If the check writer pays, 100% of the face value of the check is returned to the business, plus bank fees. The offender then

Evaluate every check

- 1. Check identification. Does the **picture** on the ID match the person presenting it? Does the **signature** on the check match the signature on the ID? If not, the check should be declined.
- Does the name and address on the check match the ID? If not, write down the correct address.
- 3. Write down the **ID number** (driver's license)
- 4. Write down the date of birth
- 5. **Initial** the upper left corner

completes a financial counseling program. If the check writer fails to pay, the check is either sent for prosecution, or if it does not meet prosecution criteria, the offender is flagged and any additional checks written will be aggregated and prosecuted at a later date.

No contract is required to participate in the program. Participants merely need to fill out a "Memorandum of Understanding" when they join. No check is too small to send through and FCTS will take checks up to 120 days old. (New participants can send in checks as old as two years!) Fraud Alert Corner: Lottery Scams

Many cons and frauds are sophisticated and can fool even the smartest people. Therefore, it is important to be aware of what different scams are out there. This month, we are going to learn more about **lottery scams**. Usually these are known as *foreign lottery scams*.

The fraud usually goes like this: the victim receives an email (or letter) stating they have won a foreign lottery (Nigeria, Australia, etc.). The victim is notified that there are fees and/or taxes associated with the winnings. The lottery will graciously send a check to cover these fees and/or taxes, "in accordance with federal law." The victim is instructed they can deposit this check (which ends up

If it sounds too good to be true, it probably is! being a fake) into their account. The victim is then to write a check to the lottery foundation in return. Once the lottery foundation receives the victim's check (which is real), the victim will receive their lottery winnings. No winnings are ever sent and the victim is out their money.

Another version of the lottery scam is an invitation to buy foreign lottery tickets via mail. All the company needs is credit card or bank account information to process the purchase.

Avoid being a victim:

- 1. Playing cross-border (foreign) lotteries are illegal in the first place. Don't do it!
- 2. You can't win a prize if you never bought a lottery ticket in the first place.
- 3. Real lotteries will not ask you for money to collect a prize. Never send money or give out personal financial information to receive your winnings.
- 4. There is no secret system to help you (or anyone else) win a lottery. Don't pay for useless information!
